*****What do we mean by state 1099 fulfillment?**

1. It is electronic. We do not offer any print and mail services.
2. Many, but not all, states require 1099 fulfillment. These states need to know basic information about 1099-type distributions and recipients. The information sent to the states is approximately equivalent to the Federal 1096 (summary page) form and the Copy A (participant information) forms.
3. In addition, some states also require their own specific 1099 reconciliation form. Often times states are interested in knowing how the distributions occurred for each quarter or month, or other information specific to the needs of that state's tax code or other regulations.
4. We do not offer state-withholding reconciliation forms. These forms (e.g. CT-945) are very similar to the Federal 945 (which we also do not offer an e-file service for). For example, these are often related to 1099 forms because tax can be withheld from distributions shown on a 1099-R form; however, these are not considered a part of state 1099 fulfillment.
5. We do not offer correction services for state 1099 fulfillment. Due to the complexity and rarity in occurrence, we do not offer corrections at this time.

Corrections: You may file corrections using the fulfillment service (batch fee applies); however, this service is not available to correct state information.
